About Us

1. Introduction: The World Human Rights Research Council is an international organization that has been actively working for the past five years in the fields of human rights, peace, justice, research, and public awareness. What began in India has now evolved into an international initiative working across different countries to strengthen awareness of human rights, promote a deeper understanding of justice, and advance respect for human dignity. More than 10,000 trained human rights activists, advocates, journalists, social workers, academicians, and legal professionals are associated with the Council, contributing to the advancement of human rights and social justice through their respective fields. WHRRRC believes that the effective protection of human rights cannot be achieved through the creation of laws alone. It requires an understanding of the law, public awareness, effective implementation, research, and active participation by society.

2. Mission: The mission of WHRRRC is to strengthen, on a broad scale, the values embodied in the Universal Declaration of Human Rights (UDHR) and to work towards ensuring that every individual has access to the knowledge, opportunities, and support necessary to understand their rights, seek justice, and live with dignity. To advance this mission, the Council seeks to empower individuals and communities through human rights research, public awareness, training, legal aid and guidance, dialogue, capacity building, and grassroots initiatives. Our work extends beyond creating awareness about rights. It also seeks to understand, identify, highlight, and address the gap between law and lived reality, while encouraging meaningful efforts towards institutional and social improvement.

3. Vision: Our vision is to build a world where human rights are not confined to laws, documents, and books, but are experienced as a reality in the everyday lives of individuals. WHRRRC envisions a global society where human dignity, equality, freedom, justice, and peace are not merely regarded as ideals, but are recognized as integral elements of social and institutional life. In the long term, the Council seeks to contribute to the development of an aware, responsible, and effective global human rights movement that strengthens human rights, peace, justice, and equality in accordance with the values of the UDHR.

4. Key Projects:

(A). KNOW YOUR RIGHTS: KNOW YOUR RIGHTS Effective protection of human rights requires awareness, education, and capacity building. With this objective, WHRRRC conducts a range of public awareness camps, training programmes, webinars, seminars, conferences, and dialogue initiatives. These initiatives bring together citizens, students, advocates, journalists, social workers, academicians, and people from diverse fields to engage with subjects relating to human rights, law, social justice, and civic responsibilities. The purpose of KNOW YOUR RIGHTS is not merely to encourage people to raise their voices for their rights, but to empower them to understand their rights, respect the rights of others, and, when necessary, take appropriate and peaceful steps to protect them.

(B). MISSION NYAY: MISSION NYAY aims to increase public awareness of citizens' rights and public service systems, while supporting a better understanding of compliance with applicable laws, rules, and prescribed standards within governmental and public institutions. Under this initiative, institutional systems may be studied and reviewed with the prior permission of the concerned department and in accordance with prescribed procedures. The initiative focuses on assessing the gap between the provisions established by law and prescribed standards and their implementation on the ground. Where appropriate, findings may be followed by suggestions, corrective recommendations, and follow-up representations before the relevant authorities, with the objective of supporting better services for citizens in accordance with applicable laws and prescribed standards.

(C). RESEARCH FOR REALITY: RESEARCH FOR REALITY is one of WHRRRC's principal research-based initiatives. Its objective is to understand, in a scientific, evidence-based, and impartial manner, the gap

between laws, policies, prescribed provisions, and their actual implementation on the ground. The project undertakes studies and research on a range of human rights and social issues. Based on the facts and findings emerging from such research, efforts are made to place reports, suggestions, and recommendations before relevant commissions, institutions, administrative bodies, and policymakers. The objective is not merely to identify problems, but also to highlight practical and policy-oriented opportunities for improvement.

(D). HUMAN RIGHTS FESTIVAL: HUMAN RIGHTS FESTIVAL aims to introduce students, from an early stage, to fundamental values such as human rights, equality, human dignity, justice, freedom, and social responsibility. Under this initiative, various educational, awareness-building, and interactive programmes are organized in schools at the high school and higher secondary levels. We believe that the earlier young people develop an understanding of human rights, the stronger will be the foundation for a generation that not only understands its own rights but also respects the rights and dignity of others.

(E). MISSION NEW LIFE: MISSION NEW LIFE is a humanitarian initiative of the World Human Rights Research Council aimed at protecting the human rights of prisoners, promoting access to justice, providing legal assistance, and supporting rehabilitation. The initiative focuses on understanding prisoners' concerns, creating awareness about their rights, and facilitating appropriate institutional and legal support wherever required. It also seeks to encourage education, skill development, positive guidance, and social reintegration, helping individuals prepare for a dignified life after incarceration. MISSION NEW LIFE represents WHRRC's commitment to justice, dignity, rehabilitation, and a second chance at life.

(F). JUSTICE FOR ALL: JUSTICE FOR ALL seeks to provide individuals in need with appropriate information, guidance, and necessary support concerning their rights, available legal remedies, and relevant institutional procedures. The Council strives to ensure that no individual is deprived of knowledge about their rights or available judicial and institutional remedies because of economic, social, educational, or other circumstances. Where necessary, and in accordance with applicable procedures, individuals may be supported in approaching the appropriate authority or forum and understanding the remedies available to them.

5. Our Approach: WHRRC believes that lasting social change cannot be achieved through institutional efforts alone. It requires the active participation of aware and responsible citizens. A citizen, researcher, advocate, teacher, journalist, or social worker can each become an agent of positive change within society through their knowledge, profession, and commitment. With this belief, WHRRC invites citizens from across the world, along with experts, academicians, advocates, researchers, journalists, and social workers from diverse fields, to become part of this mission. We value their knowledge, experience, expertise, and guidance as important contributions towards strengthening the understanding of human rights, advancing social justice, and building a more just and peaceful society.

6. Conclusion: Human rights are not merely a list of entitlements; they are fundamentally connected with the dignity, freedom, and equality of every individual. Guided by this principle, WHRRC works through research, education, awareness, training, dialogue, and grassroots initiatives to bring human rights closer to every section of society and connect them with the realities of everyday life. Let us work together towards building a society and a world where justice is not merely an ideal, peace is not merely an aspiration, and human rights are not merely words written in books—but realities experienced in the lives of every individual.
